8.8.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?	
<p>Answer: No. The Company's expenditure profile is anticipated to decrease as a result of the Completion of the joint venture agreement with Energy Fuels due to expenditure on the Donald deposit (comprising MIN5532 and RL2002) being fully funded by Energy Fuels up to \$183 million. Further, the Company is accounting for its interest in the Donald Project as a joint venture using equity accounting and therefore any future capital expenditure on the Project will be recognised as further investment in its interest in the joint venture in accordance with AASB11 and AASB128.</p>	
8.8.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
<p>Answer: The Company announced a Placement and Entitlement Offer on 17 October 2024 to raise \$13 million (comprising a Placement to institutional and sophisticated investors of \$3 million and an Entitlement Offer of 1 new CDI for every 12 CDIs held at Record Date). Of this amount, \$3 million (before costs) was received on 24 October 2024 with funds received from the Entitlement Offer expected to be received on 22 November 2024.</p> <p>All of the Company's directors (including Mr. Tiger Brown, the Company's largest shareholder), and the Company's second largest shareholder, Mr. Tan Ruiqing, have provided firm indications that they will take up their full rights under the Entitlement Offer. This represents a commitment of approximately \$7.3 million.</p>
